C. Presentation and Review of the 2026-2027 proposed budget for Arizona Virtual Academy & Insight Academy of Arizona

Covered many bullet points. Focused on the big pieces. -Enrollment increased and discussion on classroom site funds. Discussed reduction in rent for new office by 36%.
